2004 Highlights

All 71 classrooms at Aviation & Mount Rainier High Schools were adopted with each receiving a one-time award of \$100. Since 2001, the **Adopt-A-Classroom** program has awarded a total of \$44,000 to all middle and high school classrooms in the district.

Generous support allowed FFE to award **Excel Grants** to enrich classroom learning. More than \$35,000 has been distributed since inception in 2002.

The **Seattle-Tacoma International Airport Scholarship** was awarded to three Highline School District graduates. The Port of Seattle and HMS Host continue to generously fund this program through their annual STIA Scholarship Golf Tournament. \$24,000 is awarded annually.

Boeing Employee's Credit Union initiated **scholarships for teachers** pursuing their professional teacher certification. Ten teachers each received a \$100 scholarship.
